



**DECISIONS AND RECOMMENDATIONS OF THE EXTRAORDINARY
GENERAL ASSEMBLY OF THE UNION FOR ARAB ECONOMIC AND
SOCIAL COUNCILS AND SIMILAR INSTITUTIONS**

June 20th, 2022

Decisions & Recommendations of the Extraordinary General Assembly of the Union for Arab Economic and Social Councils and Similar Institutions -June, 20th, 2022-

International Conference Center- Abdellatif RAHAL- Algiers

Under the high auspices of Mr. Abdelmadjid TEBBOUNE, President of the People's Democratic Republic of Algeria, the Extraordinary General Assembly Works of the Union for Arab Economic & Social Councils and Similar Institutions were held in Algeria on the 20th of June 2022. The participating delegations from the Arab states are :

- The Hashemite Kingdom of Jordan
- The Republic of Tunisia
- The People's Democratic Republic of Algeria
- The Republic of Sudan
- The State of Palestine
- The Republic of Lebanon
- The Arab Republic of Egypt
- The Kingdom of Morocco
- The Islamic Republic of Mauritania
- The Republic of Yemen

In addition to the attendance of a delegation from the Arab Labor Organization, headed by His Excellency the General Director, Fayez Ali Al-MUTAIRI, as an observer.

After the study and the discussion of its agenda, the General Assembly members have approved the following decisions :

1. Changing the denomination of the Arab Economic and Social Councils League and Similar Institutions to the « **Union of the Arab Economic and Social Councils and Similar Institutions** » ;
2. Membership of the Tunisian National Council for Dialogue to the Union of the Arab Economic and Social Councils and Similar Institutions ;
3. The election of Pr. Dr. Sidi Mohamed BOUCHENAK KHELLADI, President of the Algerian National Economic, Social and Environmental Council, as President of Union for Arab Economic and Social Councils and Similar Institutions, for the period between 2022-2025 ;
4. The election of Mr. Moussa Ayoub CHTIOUI, President of the Jordanian Economic and Social Council, as Vice President ;
5. Amendments to a number of the Union articles.
6. Elaborating the list of the Financial Contributions for each member ;
7. Action plan for 2022-2025 ;
8. Election of the administration council members for the period of 2022-2025, which includes, in addition to the Union's president and his vice president, the following :
 - The Economic and Social Council of Palestine
 - The Economic, Social and Environmental Council of Lebanon
 - The Economic, Social and Environmental Council of Morocco
 - The Economic, Social and Environmental Council of Mauritania
 - The Arab Republic of Egypt, represented herein by Ministry of Manpower (Similar Institutions)
9. The appointment of Mr. Mohamed El-Amine DJAFRI, Secretary General of the National Economic, Social and Environmental Council of Algeria, as Secretary General of the Union for Arab Economic & Social Councils and Similar Institutions.

10. Creating a commission to study the Union aims expansion and to determine the membership criteria, as well as the fields of its activity ; provided that proposals achievement are to be completed in a maximum period of three (03) months.

Finally, the participating members express their warmest thanks and deepest gratitudes to the President of the Republic, Mr. Abdelmadjide TEBBOUNE, for the high auspices to the Extraordinary General Assembly of the Union for Arab Economic & Social Councils and Similar Institutions.

They also expressed their gratitude to His Excellency the Prime Minister, Mr. Ayman BEN ABDELRAHMAN, for supervising the Opening of the General Assembly works and for his guidance to ensure the success of this event.

On the other side, the members appreciated the dedicated efforts to reactivate this Union, in a way that grants goals achievement and ensures the enhancement of cooperation & dialogue culture between the Arab states, in order to unify the visions and confront the challenges & changes at the regional and international levels.

The participants also commended the Arab Labor Organization's efforts, headed by His Excellency the General Director, Mr. Fayez Ali Al-MUTAIRI, for his constant patronage and sustainable support.

The participating members congratulated Pr. Dr. Sidi Mohamed BOUCHENAK KHELLADI for his accession to the presidency of the Union for Arab Economic & Social Councils and Similar Institutions. They also expressed their thanks to the people and the state of Algeria, for the generous hospitality and the good organization that led to the success of this event. The participants also appreciated the remarked progress in the preparation of the Union headquarter's agreement, in order to sign it soon between

the Government of the People's Democratic Republic of Algeria and the Union for Arab Economic & Social Councils and Similar Institutions.

The participating delegations appealed for expanding the idea of establishing Economic and Social Councils to join the Union for Arab Economic and Social Councils and Similar Institutions, in order to close ranks and cooperate to improve the Arab economic and social conditions and promote dialogue between the Arab states.

In this respect, the participants appreciated the efforts of the Republic President, Mr. Abdelmadjid TEBBOUNE, aimed at unifying the Arabs for their crucial causes, in order to set stability in the Arab region and ensure sustainable development. They wished success to the Arab League Summit, which will be held on the 1st of November 2022 ; and also congratulated Algeria on the occasion of the sixtieth anniversary from regaining the National Sovereignty, corresponding with the fifth day of July.
